


END OF SEASON

The current season finishes on 31st July. Please ensure that all results are notified to the Secretary by that date. Failure to do this may result in outstanding games being scored as a loss to both players. Unfinished games can be submitted for adjudication but there is a charge for doing this. Full details of how to submit an adjudication are available from the Secretary on request.

ENTERING FOR NEXT SEASON

If you are presently a League Member and have completed your games this year you will automatically be entered into next season's contest unless you inform the Secretary by 31st July.

If you are a non-League Member, or if you failed to complete your games this season then you must tell the Secretary by 31st July if you wish to play next season.

In the last season we finished a creditable 3rd in our Division with 9 points. The winners only scored 12. Congratulations to our Team on this result and best wishes to them as they begin a new campaign. In the first round we currently lead our opponents 2-1, but there is a long way to go.

THE CURRENT SEASON RESULTS AND ADJUDICATIONS

The season ends on 31st July and all results should be sent to the Secretary by that date.

A full table of results received so far is in this magazine. If there are blanks against your name then please get these results to me as soon as possible.

I really do need results in on time if I am to be able to work out the new divisions and get next season started on time. In recent years we have been doing very well in this and your co-operation in getting results in on time has enabled me to get the next season started a little earlier, thus giving us all a little more playing time and so able to get the results in on time and so on. Don't break this virtuous circle now!

If your games are unfinished on 31st July and you cannot agree a result then they must be submitted for adjudication as follows:

BOTH PLAYERS MUST SUBMIT THE FOLLOWING

a. A cheque for $\pounds 10$ for each game to be adjudicated, payable to 'Clergy Correspondence Chess Club'. Your cheque will be returned if your claim is successful.

b. A separate piece of paper stating the **names** of each player and who is black and white. This enables me to award the points and enables the BFCC to ensure that adjudications are sent to an impartial judge. Names should **not** then appear on c,d,e,f below.

c. The **full score** of the game to the position reached.

d. A **diagram** of the current position stating which side is to move, whether castling is possible, if a pawn can be taken en passant, or anything else that is not immediately clear from the diagram.

e. Your **claim** - win or draw. You can only be awarded what you claim, nothing more.

f. **Analysis** to support your claim. This is optional but you forfeit your right of appeal if you do not submit any.

You will be notified of the result of your adjudication as soon as I receive it. If you wish to appeal you must do so within seven days, submitting all of *a*-*f* above again. You can add further analysis at this point if you wish. The fee for an appeal is $\pounds 10$, again refunded if you are successful.

Games will not be accepted for adjudication if they are not submitted correctly. If one player correctly submits an adjudication and his opponent does not then he automatically wins his claim. If neither player submits a valid adjudication then the game is scored as a loss to both players.


