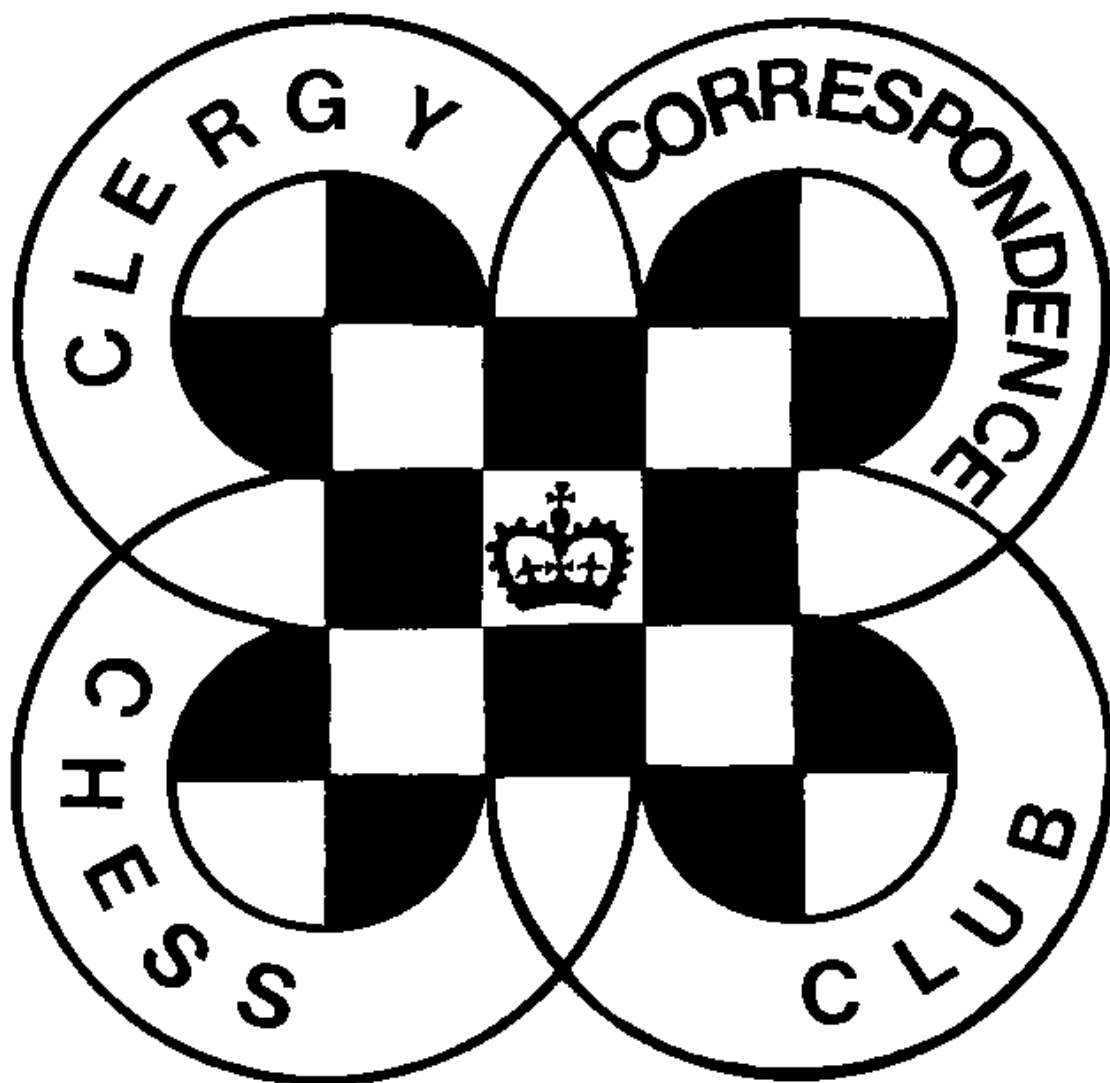
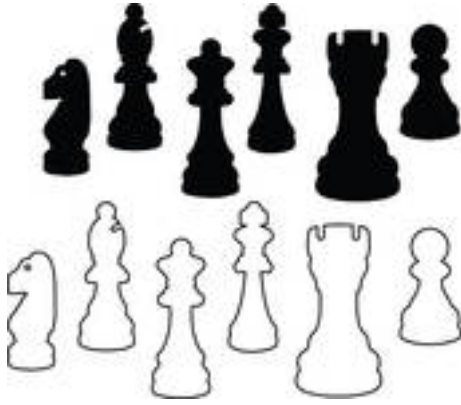

These are the results I have at the time of printing this magazine.

Division 1. Enough results are in that we know that Andrew Yates and David Lowe will be relegated! But we do not yet know who has won, with a potentially close finish between David Hulme and Mike Smith still to be resolved.

Division 2A is complete with Stephen Dunning clearly winning with 100% score. David Nye pips Brian Stevenson to second on tie break (most wins) while Tim Partridge is only half a point behind in 3rd.

Division 2B still has a few results outstanding.

THE CURRENT SEASON RESULTS AND ADJUDICATIONS

The season ends on 31st July and all results should be sent to the Secretary by that date.

A full table of results received so far is in this magazine. If there are blanks against your name then please get these results to me as soon as possible.

I really do need results in on time if I am to be able to work out the new divisions and get next season started on time. In recent years we have been doing very well in this and your co-operation in getting results in on time has enabled me to get the next season started a little earlier, thus giving us all a little more playing time and so able to get the results in on time and so on. Don't break this virtuous circle now!

If your games are unfinished on 31st July and you cannot agree a result then they must be submitted for adjudication as follows:

BOTH PLAYERS MUST SUBMIT THE FOLLOWING

a. A cheque for £10 for each game to be adjudicated, payable to 'Clergy Correspondence Chess Club'. Your cheque will be returned if your claim is successful.

b. A separate piece of paper stating the **names** of each player and who is black and white. This enables me to award the points and enables the BFCC to ensure that adjudications are sent to an impartial judge. Names should **not** then appear on *c,d,e,f* below.

c. The **full score** of the game to the position reached.

d. A **diagram** of the current position stating which side is to move, whether castling is possible, if a pawn can be taken en passant, or anything else that is not immediately clear from the diagram.

e. Your **claim** - win or draw. You can only be awarded what you claim, nothing more.

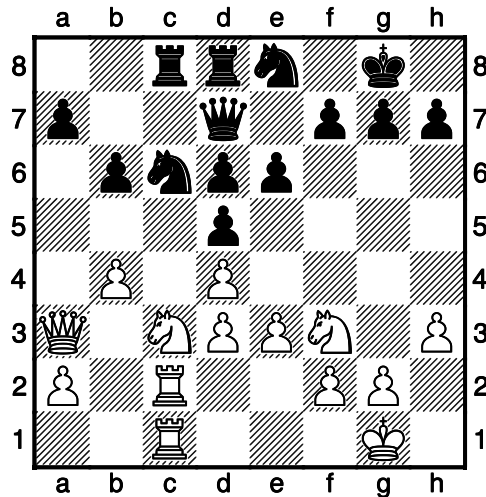
f. **Analysis** to support your claim. This is optional but you forfeit your right of appeal if you do not submit any.

You will be notified of the result of your adjudication as soon as I receive it. If you wish to appeal you must do so within seven days, submitting all of *a-f* above again. You can add further analysis at this point if you wish. The fee for an appeal is £10, again refunded if you are successful.

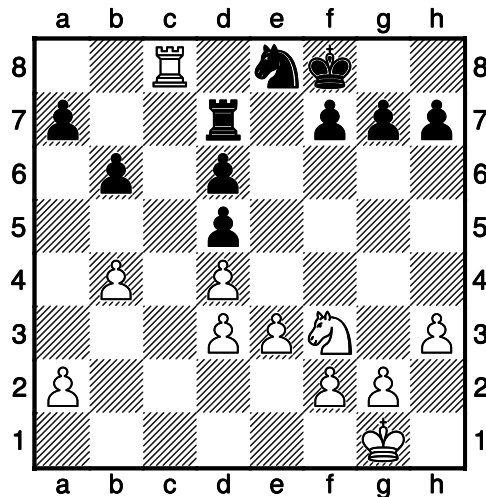
Games will not be accepted for adjudication if they are not submitted correctly. If one player correctly submits an adjudication and his opponent does not then he automatically wins his claim. If neither player submits a valid adjudication then the game is scored as a loss to both players.
